

## BYLAW 12-2011

### A BYLAW TO FIX THE WATER AND SANITARY SEWER RATES

The Council of the Town of Dundurn in the Province of Saskatchewan enacts as follows:

**1. Billings**

- a) Accounts for water service and/or sewer service shall cover a period of one month and shall be rendered on or before the first day of the month beginning such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered.
  - b) The penalty on all water and/or sewer accounts that are unpaid after thirty (30) days shall be 2% of the arrears on the combined amount, as the case may be, per month and the water service may be cut off.
  - c) When the water service is so cut off, it shall not be resumed until all arrears have been paid together with a reconnection fee of \$50.00.
2. All premises with water meters shall be read twice a year during the months of April and October.
  3. The charges to be paid by the Consumer who water service has been turned on shall be those set forth in Schedule "A" attached hereto, or as amended from time to time; provided, however that the minimum shall be payable in every case whether or not any water is consumed.
  4. Persons who own or occupy premises drained or that are by Bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached hereto, or as amended from time to time.
  5. Every property with a connection shall pay an infrastructure fee as set forth in Schedule "C" attached hereto and all costs shall be born unto the property owner.
  6. This bylaw shall come into force and take effect on the day of approval being issued by the Local Government Committee of the Saskatchewan Municipal Board and in any case no sooner than the September 2011 billing.
