OPEN PUBLIC HEARING FOR PROPOSED ANNEXATION

06.2018 Wilson/Litke – That the regular meeting is suspended to move into the public hearing at 7:00 p.m. to hear comments regarding the proposed annexation.

Mayor Vinding opened the meeting explaining the purpose of the meeting and asked if there were any submissions.

Administrator Eileen Prosser advised a notice of proposed annexation were sent to landowners the Collin's Family, landowners Carman and Vicki Dodman, Ministry of Highways and Infrastructure (MHI), Prairie Spirit School Division, Sask Energy and R.M of Dundurn #314.

The Town received written approval of the proposed annexation from the R.M. of Dundurn #314 on December 20, 2017 and a written request from Andrew Nicholls representing the Ministry of Highways and Infrastructure requesting to receive a new plan of annexation showing that portion of Hwy 211 and Hwy 11 are not part of the annexation.

Jim Walters confirmed he sent a written reply January 3, 2017 to Andrew Nicholls explaining the boundary alteration application is based on existing parcel boundaries from ICS and the Ministry of Government Relations directs urban municipalities to maintain contiguous boundaries. Jim Walters and Eileen Prosser confirmed they did not receive any further inquiries from MHI.

Gary Boehm asked what the developers were planning to build and asked about the size of land being annexed in comparison to the Sunshine Meadows development on the west side of the proposed annexation.

Administration said the owners spoke of Commercial Industrial zoning for the parcel for uses such as a truck stop and motel. Jim Walters showed on the maps provided where exactly the land is located of the proposed annexation in comparison to the Sunshine Meadows Development.

Gary Boehm asked why the land owners, who are also the Sunshine Meadows developers, wanted the land within the town boundaries and why it could not be left in the RM to develop. He wanted to know if it was because the developers wanted the town taxpayers to fund water and sewer infrastructure to the parcel. He asked if the town ratepayers would have to pay for the infrastructure.

Administration explained a development agreement would be struck and it's the rule that a developer pays for all costs associated with a development. Zero taxes from current ratepayers paid for anything in the current development and this is what would occur in any future development.

Gary Boehm had further concerns regarding how future development would impact the traffic issue coming into and leaving the town at Hwy 11. He expressed it is already a very dangerous intersection with inadequate acceleration and deceleration lanes with Hwy 11 traffic heavier each year. He is concerned that with the

Sunshine Meadows development west of Hwy 11 and potential development on the east of Hwy 11, it would lead to further dangerous crossing situations.

Administration explained a Traffic Impact Study (TIA) had been done for the Sunshine Meadows Development and sent to MHI, so they are aware of issues and it also described solutions to future traffic issues. Also, the hearing was only for annexation and if the land is requested to be sub-divided another public hearing would be required which would give further opportunity to review the impact of more traffic.

Jim Walters said that another TIA maybe required at that point by MHI. Administration mentioned the developers of Sunshine Meadows were to arrange with MHI to build a longer acceleration lane going north on Hwy 11 but was not sure of the details.

Gary Boehm expressed to Council that they along with the R.M. of Dundurn #314 should be proactive on the acceleration lane and with finding a long-term solution with MHI before it becomes even more dangerous than it is now.

Mayor Vinding asked if anyone else had any comments about the proposed annexation.

No more comments received and Mayor Vinding declared the hearing closed.

Gary Boehm, Jim Walters and Gale Hagblom left the meeting at 7:30 p.m.
