Based on recommendations from the town lawyer and from council's review:

- a) Section 4(v) Council agrees that a Nomination Committee will only <u>recommend</u> District 1 & 2 candidates to the DRWU Board to vote on.
- b) Section 4(vi) That wording is clarified and changed as follows: Municipal appointments to the Board shall be made by resolution of each respective municipal council. A Municipal appointed Board Director may be removed at any time by the Council appointing them. District 1 & 2 Board Directors who are appointed by the DRWU Board may be removed by the DRWU Board at any time.

NOTE: Due to the mention of a Nomination Committee in the corporate agreement the town lawyer recommends that a section is included defining it. IE: how many members, can they be board members or non-board members, terms if any, duties/powers etc.

- c) Section 4(a)(viii) change to: Hire an Administrator.
- Section 4(a)(ix) change to: Hire employees and appoint individuals as necessary.
- e) Section 4(b)(i) change to: New appointed members will sign the oath of office as per Schedule C.
- f) Section 4(e)(v) add in an appropriate time to submit draft minutes to the corporate partners for review.
